1. Acceptance of Terms

These Terms of Service ("Terms") constitute a legal agreement between you and Compass AI Data Services, LLC ("SentiSense", "we", "us", or "our") governing your access to and use of the SentiSense platform, including our website at sentisense.ai and any related services, features, content, and applications (collectively, the "Service" or "Platform").

By accessing or using the Platform, you acknowledge that you have read, understood, and agree to be bound by these Terms. If you do not agree to these Terms, you must not access or use the Platform.

Certain features of the Platform are accessible without creating an account. Anonymous browsing is subject to these Terms. Creating an account or using features that require authentication constitutes additional acceptance of these Terms.

3. Description of Service

SentiSense is an AI-powered market intelligence platform that provides information, data, and analysis tools to help users conduct market research. The Platform is designed for informational and educational purposes only.

Beta Status and Limited Coverage (February 2026)

The Platform is currently in Beta. As of February 2026, our stock coverage includes the S&P 500 index constituents (approximately 500 stocks) with in-depth reports prepared by our team with the help of AI. We plan to continue expanding coverage to additional stocks and exchanges in future releases. During the Beta period, features, functionality, and data coverage may change without notice. Some features may be incomplete or experimental, and service availability may vary.

Core Features

Insights & Alerts: The platform generates insights for stocks using a combination of AI models and algorithmic analysis of news, social media, and market data. Free users may see a limited preview of insights; full access to personalized insights for stocks in your watchlist and related alerts requires a PRO subscription.

Stock Analysis Reports (PRO only): Our "Deep stock analysis" feature provides AI-generated analysis reports on individual stocks as well as aggregate market summaries, synthesizing information from multiple data sources.

Stories (News Clustering): AI-powered system that automatically detects, clusters, and summarizes evolving financial news narratives, grouping related articles and posts into coherent stories. Anonymous visitors may view up to 3 full stories per browser session; authenticated FREE users receive limited monthly previews; full unlimited access to all stories requires a PRO subscription.

Institutional Tracker: The Platform provides institutional flow data derived from publicly available SEC 13F-HR filings, including aggregate buying/selling activity by institutional investors, individual stock holder breakdowns, activist investor positions, convertible bond flows, and options activity. This data is subject to inherent delays (filings are due within 45 days of quarter end) and does not capture all of an institution's positions or strategies. Free and unauthenticated users may view a limited preview; full access requires a PRO subscription. Institutional data does not constitute investment advice or a trading signal. See our Disclaimer for additional details and limitations.

Market Data: The platform displays market data including stock prices, basic market information, and sentiment scores derived from news and social media analysis (including the SentiSense Score). Core sentiment metrics are available to all users on every tier. Advanced sentiment analytics may require a PRO subscription.

Proprietary Indexes: The Platform may feature proprietary composite indexes derived from our curated data pipeline. These indexes, such as Market Mood and SentiSense Score, combine AI-analyzed signals from news sentiment, social media activity, and market data into composite data points. Proprietary indexes are not sourced from any third-party index provider and are calculated exclusively by SentiSense. **Because these indexes are derived from AI-analyzed and algorithmically processed data, they are inherently prone to errors, inaccuracies, and limitations. Proprietary indexes do not constitute investment advice, recommendations, or endorsements of any kind and should not be relied upon for any investment decision.** We reserve the right to modify, suspend, or permanently discontinue any proprietary index at any time, without notice and for any reason, including if we determine that maintaining such index no longer provides sufficient value. Watchlists: Ability to create and manage lists of stocks you wish to track, with information filtered to show content relevant to your watchlist.

News and Social Media Streams: Access to curated streams of news articles and social media posts related to stocks and market events.

Data API: SentiSense provides a REST API ("Data API") that enables programmatic access to platform data, including stock prices, news documents, sentiment analysis, institutional flow data, and insider trading data. API access requires an API key, generated in the Developer Console within your account settings. API availability, endpoints, response schemas, rate limits, and features may vary by subscription tier and are subject to the Data API Terms in Section 4A below.

Portfolio Tracking: (Currently unavailable) Third-party brokerage account connection features are not currently active.

Agentic AI Features

The Platform employs agentic AI systems that operate behind the scenes to process data, generate analysis, and create insights. These systems use:

- Multi-step reasoning and tool calling

- Structured information extraction from unstructured data
- Trend and anomaly detection across data sources
- Automated clustering and summarization of news narratives

Note: AI-generated content is provided through pre-computed reports, insights, and news clustering (Stories). The Platform includes chatbot functionality that may be enabled for certain users via feature flags, but is not generally available to all users.

4. Subscription Tiers and Features

SentiSense offers two subscription tiers: FREE and PRO. Features and quotas vary by tier.

Anonymous Access (No Account Required)

Certain Platform features are available without creating an account:

- Browse stocks listing and stock detail pages
- Browse news, social media, and content feeds
- View up to 3 full story reads per browser session
- View market summary and publicly available data
- View limited preview of institutional tracker and insider trading data

Anonymous access is subject to session-based limits and may be restricted at our discretion. Features that require personalization (watchlists, alerts, insights) require account creation.

FREE Tier (Account Required)

- SentiSense Score and per-stock sentiment metrics (unlimited)
- Stock reports (10 per month)
- Stories (limited previews, up to 10 full reads per month)
- News and Social Feeds (News, X, Reddit) (unlimited)
- Market Mood index (unlimited)
- Create and manage watchlists
- Institutional Tracker and Insider Trading (limited preview)

- API access: 1,000 requests/month
- Email support
- No stock analysis features
- No alerts

PRO Tier (\$15/month or \$144/year)

- Everything in Free
- Stocks dashboard with full sentiment tracking and real-time market data (unlimited)
- Deep stock analysis
- Stories Stream: all stories unlocked, unlimited views
- Institutional Tracker: full access to all institutional flow and insider trading data
- Data API access: 100,000 requests/month (60 requests/minute)
- Alerts
- Priority support

Note: Features, quotas, data sources, and pricing are subject to change as we improve the platform. We will provide advance notice of material changes to paid subscriptions. Data sources and AI capabilities may be updated, enhanced, or changed over time to improve service quality.
